

PROGRAM OVERVIEW

NHTSA's Traffic Records GO Team program is designed to provide resources and assistance to state traffic records professionals as they work to better their traffic records data collection, management, and analysis capabilities.

GO Teams help states improve their traffic records systems by deploying teams of your peers from around the country as subject matter experts to deliver tailored technical assistance and training to help states address a variety of traffic records issues, including Traffic Records Coordinating Committee management, strategic planning, and data integration.

NHTSA is now offering GO Team technical assistance and training to support State Traffic Records Coordinators.

WHAT TYPE OF TRAINING AND TECHNICAL ASSISTANCE IS PROVIDED BY A GO TEAM?

The State Traffic Records Coordinator GO Team's technical assistance and training are tailored to the needs identified by the state, but may include familiarization and support with:

- ✓ TRCC Coordinator best practices and tips;
- √ Traffic records resources, such as a list of fundamentals or tools for TRCC Coordinators;
- Strategic planning; Stakeholder engagement;
- ✓ TRCC management objectives/ principles; and
- ✓ Data governance.

The SMEs selected for a State Traffic Records Coordinator Training GO Team will have extensive experience and direct knowledge related to the needs of the state. The SMEs have helped develop NHTSA's strategic planning workshop, have worked directly with many of the states' traffic records programs, and are passionate about sharing their experiences as successful State Traffic Records Coordinators.

REQUESTING A GO TEAM

How do states request a GO Team to support a State Traffic Records Coordinator?

A state interested in requesting a GO Team should contact their Regional Program Manager for more information or assistance with the application process.

Who submits the application?

A state-designated representative approved by both the State Highway Safety Office and TRCC should be submitted to the NHTSA Regional Office.

How much does a GO Team cost?

GO Teams are available at no cost to the state.

When will the GO Team begin?

Applications are accepted on a rolling basis throughout the fiscal year, and GO Teams will be deployed on a first-come, first-serve basis. Once an application has been reviewed and approved, NHTSA will contact the state representative to schedule the GO Team deployment.
